El 100.00% del espacio está incluido en el 'Pla d'Espais d'Interès Natural' (PEIN), aprobado por el Decreto 328/1992 de la Generalitat de Catalunya. En concreto el 93.02% pertenece al PEIN Muntanyes de Rocacorba, el 6.98% a Puig de la Banya del Boc. La inclusión de estos porcentajes en PEINs implica un grado de protección en parte del lugar que no queda reflejado en el Apartado 5.1 del formulario, ya que la figura PEIN no está recogida en el mismo.
